



# WEDDING PHOTOGRAPHY SERVICES AGREEMENT

## REAL LIFE IMAGES LLC

1. **ENTIRE AGREEMENT**

This Agreement constitutes the entire agreement between the Parties and supersedes all prior discussions, understandings, or agreements, whether oral or written. Any amendments or modifications must be in writing and signed by both Parties. If any provision is found unenforceable, the remaining provisions remain in full force and effect. No waiver of any breach shall be deemed a waiver of any subsequent breach.

2. **RESERVATION AND RETAINER**

A signed Agreement and a nonrefundable retainer are required to reserve the wedding date and time. The retainer secures Company's availability and is applied toward the total contract price. Retainers are non-refundable under all circumstances. Retainers may be transferred to a new date only when rescheduling occurs more than two (2) weeks prior to the scheduled wedding date and is subject to availability. Cancellations without rescheduling, or cancellations made within two (2) weeks of the scheduled wedding date, will result in forfeiture of the retainer.

3. **BOOKING ACKNOWLEDGMENT AND ACCEPTANCE**

Client acknowledges that booking policies, including retainer, cancellation, payment, delivery, and usage terms, were reviewed and accepted at the time of booking. This Agreement further outlines wedding day coverage, expectations, and responsibilities and supplements those terms.

4. **SERVICES AND COVERAGE**

Company will provide photography coverage for the wedding during the scheduled coverage times listed above. Coverage begins and ends at the agreed times. Late starts, delays, or changes caused by Client, venue, or guests do not extend coverage time. Client agrees to provide a final wedding timeline no later than seven (7) days prior to the wedding date and to designate a point of contact to assist with coordination on the wedding day.

5. **ACCESS, SETUP, AND COOPERATION**

Client shall ensure Company has reasonable access to all locations and conditions necessary to perform services. Client agrees to assist in coordinating wedding party members and family for photography as needed.

6. **ADDITIONAL COVERAGE TIME**

Additional wedding coverage may be added based on availability at a rate of one hundred fifty dollars (\$150) per hour. Any portion of an hour is billed as a full hour.

7. **PAYMENT TERMS**

Final payment for wedding coverage is due no later than twenty-four (24) hours prior to the wedding date. Failure to remit final payment may result in suspension or termination of coverage without refund.

**8. PAYMENTS, PROCESSING, AND FEES**

Online payments are processed securely through PayPal and Square and are subject to their respective terms and conditions. Checks must be made payable to Real Life Images LLC and are subject to a thirty-five dollar (\$35) returned check fee. Check payments may take up to thirty (30) days to process after receipt.

**9. TRAVEL AND EXPENSES**

The first fifty (50) miles round trip are included. Mileage beyond fifty (50) miles round trip is billed at fifty-five cents (\$0.55) per mile. Travel time beyond standard local coverage is billed at seventy-five dollars (\$75) per hour. If airfare, lodging, meals, or other travel expenses are required, those costs will be included in the final quote.

**10. GUEST INTERFERENCE AND CAMERA USE**

Guests may not interfere with Company's duties. Guests may capture behind-the-scenes content using a mobile phone provided it does not disrupt coverage. Guests may not act as additional photographers or use professional camera equipment. Company may restrict camera phone use in designated photo areas if such use interferes with coverage.

**11. ARTISTIC STYLE, EDITING, AND IMAGE SELECTION**

Client understands photography is a creative service. Editing style, image selection, and final delivery are based on Company's professional judgment. Company does not guarantee delivery of any specific image, individual, or moment. Raw or unedited image files are not delivered under any circumstances.

**12. DELIVERY TIMELINE**

Wedding delivery timelines are confirmed in writing based on coverage scope and post-production requirements and will not exceed thirty (30) calendar days unless otherwise specified in writing.

**13. COPYRIGHT AND CLIENT USE**

All images remain the intellectual property of Company and are protected under United States copyright law. Upon full payment, Client is granted a limited personal use license for sharing and printing. Commercial use is prohibited without written consent.

**14. MODEL RELEASE**

Client grants Company the irrevocable right to use images from the wedding for portfolio, marketing, advertising, and promotional purposes unless otherwise requested in writing prior to the wedding date.

**15. LIABILITY AND FORCE MAJEURE**

Company's liability for failure to perform due to circumstances beyond its control is limited to a refund of amounts paid. Company is not liable for indirect, incidental, or emotional damages.

**16. GOVERNING LAW**

This Agreement shall be governed by the laws of the State of Georgia.
